## ASSUMPTION OF RISK AND RELEASE OF ALL LIABILITIES, CLAIMS, AND INJURIES

### Please Read Carefully Before Signing

This Assumption of Risk and Release of all Liabilities, Claims and Injuries is required to be executed, at the sole discretion of Greenville Woodworkers Guild, Inc. (the "Guild") and its authorized agents, prior to participation in any activities on its premises known as Greenville Woodworkers Guild Education Center located at 701 Poinsett Highway, Greenville, South Carolina, 29609 (the "Premises"). These activities may include, but are not limited to, using woodworking and other machinery, equipment and tools located on the Premises.

I, \_\_\_\_\_, as a member of the Guild and/or a participant (or parent or legal guardian of a participant) in certain activities on the Premises, as a condition to using the facilities at the Premises, agree to participate (or allow the child named below, of whom I am a parent or legal guardian, to participate) in any activities at the Premises completely at my own risk.

I acknowledge that the woodworking and other machinery, equipment and tools located on the Premises are dangerous. I represent and certify that I understand the risks involved in using such machinery, equipment and tools and in participating in other activities on the Premises and willing assume full responsibility for myself (or the child named below, of whom I am a parent or legal guardian) for expenses (including attorneys fees and costs of litigation), loss of personal property, bodily injury and/or death arising out of, or in any way connected with, my participation (or participation of child named below, of whom I am a parent or legal guardian ) in activities on the Premises.

Without limiting the foregoing, I agree that neither the Guild nor Hartness International, Inc. (the "Landlord"), or any other person associated with the Guild or the Landlord, including but not limited to their respective directors, officers, employees and agents (the Guild, the Landlord and such other persons are referred to collectively as the "Released Parties"), shall be liable for any damages, including but not limited to those arising from personal injuries sustained by me (or the child named below, of whom I am a parent or legal guardian) in or about the Premises, whether or not caused by negligence of any of the Released Parties. This means that I assume all risks, known and unknown, involved in participation in any activity on the Premises and will hold the Released Parties harmless for any damages or injuries that I (or the child named below, of whom I am a parent or legal guardian) may sustain in the pursuit of any activity while on or about the Premises. I assume full responsibility for any injuries or damages that may occur to me (or the child named below, of whom I am a parent or legal guardian) in or about the Premises and fully and forever release and discharge the Released Parties from any and all claims, demands, damages, rights or causes of action, whether present or future, known or unknown, anticipated or unanticipated, resulting from or arising out of my use (or the use by child named below, of whom I am a parent or legal guardian) of the woodworking and other machinery, equipment and tools located on the Premises and/or in any other activities on the Premises.

I further agree to abide by and follow all applicable rules, policies and procedures of the Guild during my use (or the use by child named below, of whom I am a parent or legal guardian) of the facilities on the Premises. In addition, I agree to immediately report any injuries or property damage or any condition that could be dangerous to others to a representative of the Guild who is then present on the Premises.

I HAVE READ AND UNDERSTAND THIS ASSUMPTION OF RISK AND RELEASE OF ALL LIABILITIES, CLAIMS AND INJURIES. I AM UNDER NO INDUCEMENT TO SIGN AND REALIZE THAT BY DOING SO, I GIVE UP SUBSTANTIAL RIGHTS ON BEHALF OF MYSELF (AND THE CHILD NAMED BELOW, OF WHOM I AM A PARENT OR LEGAL GUARDIAN).
